3. New Initiatives

3a. Student and Young Professional Research Achievement Award. Aisling Fernandez presented a proposal for an OPHA Epidemiology and Biostatistics Student and Young Professional Achievement award. The award would be for advancing public health knowledge and/or practice. The award would be for up to \$500 to attend a public health conference and would be paid for by the section. The proposal was accepted for one year in hopes that it would be awarded at the October OPHA annual meeting.

Jim Gaudino talked about the Congress of Epidemiology (a consortium including the American Public Health Association and the American College of Epidemiology) that has had 3 international meetings (2001, 2006, 2011).
